

Notification of mass (and/or speed) limits on bridges

Regulation 11, Heavy Motor Vehicle Regulations 1974

Notice is hereby given that pursuant to *regulation 11(3)* of the *Heavy Motor Vehicle Regulations 1974*, the Central Otago District Council has fixed the following maximum mass and speed limits for heavy motor vehicles and combinations including a heavy motor vehicle on the bridges described hereunder:
