Public Notice of decision on Plan Change 21 to the Central Otago **District Plan.**

Corrected appeal close date. Pursuant to Clause 10 (4) (b) of Schedule 1 to the Resource Management Act 1991 the Central Otago District Council has given its decision on Plan Change 21 to the Central Otago District Plan and on matters raised in submissions and further submissions thereto.

Plan Change 21 was requested by Fulton Hogan Limited to re-zone approximately 120 ha of land at Parkburn Quarry. The purpose of the plan change is to provide for a future use of the site, post quarrying activities, by providing for a range of urban zonings (residential, industrial and business).

The site is bordered to the west by SH6 and adjoins Lake Dunstan to the east. The boundary to the south is the edge of the current urban area of the Pisa Moorings settlement. The boundary to the north contains another quarrying activity

The specific zonings sought through PC21 are:

- 81.15ha of land to Residential Resource Area / Low Density (a) Residential:
- 10.09ha of land to Residential Resource Area / Medium Density (b) Residential;
- 4.72ha of land to new Business Resource Area (3);
- 2.32ha of land to new Industrial Resource Area (2); and (d) 22.28ha of land to new Industrial Resource Area (3). (e)

Plan Change 20 proposes to amend Section 11 - Heritage Precincts to: i. Add additional matters of discretion to those rules requiring a

- resource consent for the addition or alteration of structures, or the erection of new structures, within a heritage precinct (Rules 11.4.1(a) and 11.4.1(b)); and
- ii. Add a requirement for resource consent applications made under these rules to undertake an assessment against any relevant guidelines, and to note the potential requirement for a heritage impact assessment to accompany the application (Rule 11.4.1A); and
- iii. Introduce new Heritage Guidelines to guide future additions, alteration of structures or the construction of new structures in a Heritage Precinct.
