- Lots 1-20 will be freehold lots for residential activity. The lots range in size from 1502m² to 2265m².
- Lot 30 is a 4100m² recreation/local purpose reserve
- Lot 40 is a 4.44ha balance freehold lot intended for future development
- Lot 50 is a 7.82ha balance lot intended for future development
- Lot 51 is a 0.53ha balance lot

The site is zoned Residential Resource 4 under the operative District Plan and Large Lot Residential under Plan Change 19.

A Building Line Restriction is identified on the entire east to north facing slopes of the escarpment and lower parts of the hillside down toward the Bannockburn Inlet.

Resorce Management Act 1991 Public notice of decision on plan change 22 to the Central Oatgo District Plan

Pursuant to Clause 10 of Schedule 1 to the Resource Management Act 1991 the Central Otago District Council has accepted the recommended of its Hearings Panel on Plan Change 22 (PC22) to the Central Otago District Plan and on matters raised in submissions and further submissions. Plan Change 22 (PC22) proposes a new chapter (Chapter 20) to the Central Otago District Plan. The new chapter applies to specific areas subject to a Dark Sky Precinct. PC22 includes the identification of a new Dark Sky Precinct over the Naseby Township and allows for the creation of further precincts in the future.
