PUBLIC NOTICE PLAN CHANGE 19 TO THE CENTRAL OTAGO DISTRICT PLAN

Pursuant to clause 5 of the First Schedule to the Resource Management Act 1991 the Central Otago District Council has prepared Plan Change 19 to the Central Otago District Plan to:

- Amend revise planning Maps by rezoning any land currently zone 'Residential Resource Area' to new Large Lot, Medium Density and Low-Density Residential Zones.
- Delete Chapter 7 of the Central Otago District Council Operative District Plan in full and replace with a new 'Residential Zones' chapter.
- Insert new definitions from the national planning standards to apply to the new residential chapter provisions.
- Make consequential changes necessary to other parts of operative Central Otago District Plan.

The following persons may make a submission on the proposal:

- the local authority in its own area may make a submission; and
- any other person may make a submission but, if the person could gain an advantage in trade competition through the submission, then the person may do so only if the person is directly affected by an effect of the proposal that
 - o adversely affects the environment; and
 - o does not relate to trade competition or the effects of trade competition.



You may make a submission by sending a written or electronic submission to the Central Otago District Council at PO Box 122, Alexandra 9340 or by email to <u>districtplan@codc.govt.nz</u>.

The submission must be in Form 5 and must state whether or not you wish to be heard on your submission. Copies of Form 5 are available at the locations listed above or on request from the Central Otago District Council.

Submissions close at 4.00pm on Friday 2nd September 2022.

The process for public participation in the consideration of the proposal under the Act is as follows:

- after the closing date for submissions, the Central Otago District Council must prepare a summary of decisions requested by submitters and give public notice of the availability of this summary and where the summary and submissions can be inspected; and
- there must be an opportunity for the following persons to make a further submission in support of, or in opposition to, the submissions already made:
 - o any person representing a relevant aspect of the public interest.
 - o any person who has an interest in the proposal greater than the general public has.
 - the local authority itself; and
- if a person making a submission asks to be heard in support of his or her submission, a hearing must be held; and
- the Central Otago District Council must give its decision on the proposal and matters raised in the submissions (including its reasons for accepting or rejecting submissions) and give public notice of its decision within 2 years of notifying the proposal and serve it on every person who made a submission at the same time; and
- any person who has made a submission has the right to appeal against the decision on the proposal to the Environment Court if, in relation to a provision or matter that is the subject of the appeal, the person referred to the provision or matter in the person's submission on the proposal.
