No submission number given for reasons outlined below:

The submitter requested my assistance earlier this year to help him write his submission opposing the reduction in the 4000 sqm minimum section sizes in RRA6. He physically lodged his submission at the Cromwell office of the CODC before the closing date (2<sup>nd</sup> September 2022) and he retained a date stamped copy.

The Summary of Submissions was finally released to submitters on 5<sup>th</sup> December 2022, allowing 12 working days to lodge a Form 6 Further Submission Form by 4 pm 20 December. I noted that the submitter's submission did not appear on the summary and informed the submitter of this on 13 December and he promptly made inquiries at the Cromwell office, with his date stamped copy in hand. His original submission was then emailed to Ann Rogers at CODC in Alexandra, who told the submitter his original lodged submission

had 'gone missing' between the 2 offices. Ms Rogers contacted the submitter and apologised and stated his submission would immediately be added to the Summary of Submissions and individually uploaded with all the other submissions immediately. However, 6 working days later the submission still has not appeared on the CODC website.

The submitter then rang Ms Rogers again this afternoon and as at 2.27 pm today, 20 December, it still does not appear on Council's website.

After checking with the submitter, he confirms he opposes the proposed plan changes to reduce the size of the sections in RRA6 and supports retaining the 4000sqm minimum section size.

I seek that the whole of the submission be allowed and an assurance from CODC that there are no other submissions that have 'gone missing', either now or in the future.

I wish to be heard in support of my further submission.

If others make a similar submission, I will consider presenting a joint case with them at a hearing.
