The positives, both economic and social, for Cromwell of the Highlands Motorsport Park are huge. A condition of the sale of the endowment land which Highlands occupies was that it must be used for the "social and economic benefit of the community". Highlands fulfils these conditions admirably.

A residential development of the scale proposed in plan change 13 puts Highlands at serious risk. Already, plans for a \$50 Million golf resort are on hold for fear of this pan change being approved.
