Public Consultation

For a plan change of this importance the elapsed time between 11 April 2018 when the Plan Change was considered by council and the 20 May 2018 has not allowed time for meaningful consultation with the public.

Section 32 (2) of the Resource Management Act states "Identify and assess the benefits and costs". I would expect the Council to carry out their own assessments that includes Public consultation instead of adopting the RTDL Document 4 to fulfil this obligation.

No-Complaint Covenant

The potential for this Plan Change affecting the operation of the Highland Park Racing, The Speedway and Orchard Operations is a major concern. RTDL plan to address this issue by way of a covenant however there is very little information given on the legal status of such a covenant and whether it would be binding on subsequent owners and prevent the possibility off a class action being taken in the future.

Highland Park and the Speedway have become icons the Cromwell residents are very proud of and any threat to their operation must be taken seriously.

I therefore oppose the Plan Change 13 proposal.
