I wish to object to the proposed housing development bordering Sandflat Road and SH6.

This will have adverse effects on the already established Orchards, Speedway, Highlands Motorsport Park (all of which attract thousands to area annually) the Airport as well as adjacent housing. While they might say people will not object to the sprays and noises they will just as they do with other developments such as The Dunes and Pisa Moorings.

There is ample land around the Wakatipu Basin to accommodate extra housing, please don't let the Cromwell area become the only option for increased housing to accommodate Queenstown workers and backpackers.
