My reasons are:

- 2. Restrictions placed on the Highlands Motor Sports Park.
- 3. Restrictions placed on the orchards adjacent to SHW 6 in the event of frost fighting, pest control and the use of wind machines.
- 4. The economic loss should the Highlands Motor Sports Park be forced to close.
- 5. The economics loss to the town of Cromwell should orchards be forced to close due to noise complaints. Restrictions placed on horticulture spraying.
- 6. Restrictions on employment opportunities.
