I am a Highlands member and property owner in the Highlands Innovation and Technology Park.

Council originally sold Endowment land for the development of a motorsport park (Highlands) because they obviously believed it was an appropriate site away from residential activities where motorsport activities already existed (Cromwell Speedway) and would be an asset with long term benefits for the community.

This has proven to be a wise decision by Council, as Highlands has truly benefitted the community with economic prosperity rising at an unprecedented rate since opening. At every major event the Mayor or one of the councillors always make a speech praising Highlands, describing it as a shining star for what it has done for Cromwell and the greater Central Otago Area.

High density residential and rest home right next door to two motorsport parks would have to be viewed as a major conflict and a recipe for ongoing issues for generations to come.
