 I wont renew my License, is a  
 just one, its your duty as Council  
 to give justices to all parties,  
 you must consider the fact that  
 it now costs a Bonefyed Hawker  
 £15 ~~per~~ per year to travel on Burness  
 Vincent County with the Courts  
 of Cornwall & Alexandria  
 you must remember that

The Storekeepers of Alexandria  
Hawk their Goods all over the  
County from Bald Hills Flat on  
to Jda Valley; they carry the same  
kinds of goods as I do & pay no  
taxes or license; the same can be  
said with those Merchants of  
Cornwall they run their  
Hawking Business from Bamwell  
on to the Hawden; I am in no  
ways interfered with; now remember  
these Storekeepers protect their own  
towns with a yearly License of £5  
& they dare me to go on with  
my Business; unless I pay the tax,  
you will see my request is  
only a just one; your watchman  
had the Confidence to tell me  
that the Council did not desire  
him to interfere with local  
men; I may remark that I

drew Councilor Shepard  
attention to the Alexandria  
Storekeepers; Hawking in  
Blacks on Jan last, & I was  
told by Mr Shepard that according  
to the laws of Vincent-Count Council  
they ought to pay a License  
I may tell you that I now give  
my written word of Honor  
that I shall pay this year License in  
full & any latter year that I  
may travel & I shall give the  
Council a personal visit early  
in July when I will give them  
regular eye opening facts in plain  
words; I may remark that

Gentlemen

The enclosed letter written by Mr A Souther Hamker of Dunedin was handed to me by Mr Decker the County Clerk — In reply I may state I saw Mr Alexander Souther going up to Timber's on or about the beginning of March last last he defied me to make him take out a Hamkers License though he would Hamk in the County. I advised him not to contend against the Legal Powers that existed as it would not cost us nothing to put them into force

On Wednesday the 21<sup>st</sup> inst about 5 P.M I saw Mr A Souther pass through Clyde and he continued the Road to Bad Hill Flat I next Morning went in pursuit of him. Thinking to find him well settled down to business by the time I should arrive at Bad Hill Flat. I got there about 1 P.M I tracked him to Councilors Butters Residence & from there I saw the Van at

Vincent County Council.

Clyde..... 188.

Mr Constanthine Murphys place from there he went to Mr Hugh Crossans place & from there to Mr Harry Prosser's place & from there to Mr Burton Hotel Bad Hill Wat this was about 2 P.M or a little after -

In about a half an hour after I saw him coming from Burtons Hotel up the road toward me I then went toward him I spoke to him regarding <sup>his</sup> ~~the~~ Hawkers License to Hawke in the County - and he treated me to what the enclosed letter is a Counter Part

In reply to his letter I do not see anything to reply to except where he states that your watchman had the confidence to tell me that the Council did not desire him to interper with local men, that statement is not true but a base lie, and as far as his scurrulous remarks apply to me in his letter I can treat them with the contempt that they deserve

I have the honor to report  
re. an Licensee, Hawkers and Pedlers, that  
on the 18<sup>th</sup> November George Solomon a Pedler  
was fined 5/- and cast in the M.M. Court  
Clyde, for pedling in Sutherland street on the  
30 October without a License -

A summons is awaiting, a Pedler name  
unknown for pedling or selling in Sutherland  
street Clyde on the 1<sup>st</sup> November -

Alfred Henry Smith. Hawker was on the  
3<sup>rd</sup> inst. convicted and fined £2.0.0 and cast of  
court. £1.9.0 for Hawking without a License on the  
Cromwell on the 31<sup>st</sup> October -

On Saturday afternoon the 26<sup>th</sup> October I  
saw Alexander Suther a (Hawker) on the Road  
to Black. I ask<sup>d</sup> him to show me his License  
he said he had none, he said he would send  
the money into the County Clerk by the Tuesday  
Coach, he did so and obtained an Hawkers -  
License -

over

On the 26 October Saturday Morning I saw Mr Sweetland the representative of the D. J. C. - Hawking in Clyde. I ask<sup>d</sup> him to show me his Hawkers License, he contended that he was not Hawking, I produce the County Bye Law n<sup>o</sup> 3 and I pointed out to him section 12 which he which he read, I told him he could see what chance he had - as my instruction was to fight the matter out, he said he would send a Delegation to Dunedin at once, on Monday Morning Mr Sweetland took out a Hawkers License -

On Monday Morning 11<sup>th</sup> November I saw Mr Nicolson (of the firm of Brown Emery & Co) call at a number of Houses in Clyde but he had no Parcel with him that I could see and on the 19 November Tuesday afternoon I went in pursuit of Mr Nicolson I found him at Bald Hill Flat, I asked him to show me his Hawkers License he said he did not sell anything out of his trap, I wanted him to read the Bye Law n<sup>o</sup> 3 - section 12 but he would not he said he was doing Business the same as any other Commercial Traveller was doing, and if he had to take out a Hawkers License every Commercial Traveller upon the road would have to do the same

I conferred with Mr J. S. Dickie - County Clerk hence I have written a letter to Messrs Brown Emery & Co a Copy of which I herewith enclose.
