ORDER PAPER.

Mr. Treasurer to move:-

That in pursuance of the Resolution passed by this Council on November 25th 1886. for borrowing the sum of £3000 under the Government Loan to Local Bodies Act 1886. this Council now authorizes the Chairman to give effect to said Resolution by publishing Notices in conformity with Section 33. of "The Local Bodies Loans Act 1886."

Mr. McCarty seconded

Mr. McCarty to move:-

That a sum not exceeding thirty Pounds (£30) be voted towards repairing the road known to Albert Inn -
Mr. McCarty

Mr. Sheppard - That the sum in and around Quakers Dapwood Downshire be paid in repairing before the coming winter -
not exceeding £50 - Mr. Pithers

Mr. McCarty - That the old stone bridge be put in at Beaumonts crossing above the Linn -

Mr. Pithers - That the Engineer be instructed to let the road from Mr. Burrows to Jan Valley to form an additional repair at a cost not exceeding £15 -
Mr. Sheppard and carried

Mr. Sheppard - That the road through Glen Lough to be made so as to give access to that portion of the road already completed by the Main Roads and Vincent Counties Co-Partnership
