Thank you, Jake, for providing me with a copy of your evidence for resource consent application RC240234. As you are aware, NZTA made a neutral submission on that resource consent application and sought two conditions be imposed on the consent, should the Council be minded to grant the consent, to manage reverse sensitivity noise effects and to facilitate authorisation of the use of the vehicle crossing onto the state highway via a Crossing Place notice pursuant to the Government Roading Powers Act 1989. The author of the Council's Section 42A report has recommended that the two conditions sought by NZTA be imposed on the consent, as conditions 12 and 19. Your evidence confirms your client accepts the imposition of conditions 12 and 19. Given the acceptance of those two conditions by both the applicant and the Council's s42A report author, NZTA no longer intends to attend the Hearing.
