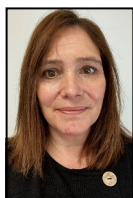

I bring a fresh outlook from a younger working family-oriented perspective, with a wealth of pertinent experience in key areas for our region.

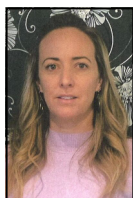
I am heavily involved in several sports as a coach, mentor, manager and committee member.

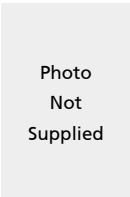
I am in favour of defunding LGNZ.

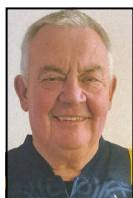

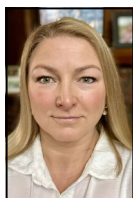

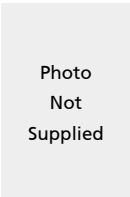
My principal place of residence is in the Vincent Ward area. I am also standing for Vincent Ward Council.

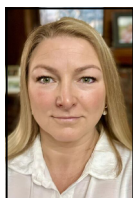
