The location chosen is within the town, just as you drive into the area - this deters visitors as it will be such an eyesore. As a community we have put time, money and effort over many years to make and keep the town looking welcoming and bright and this will take away all that hard work and likely deter visitors from stopping. This will impact businesses and many will drive on through to Palmerston rather then be near the potential risk factors.

Environmental Impact - Soil/Bloom/Air Quality (if a fire occurred)

This will create a "solar heat Island effect" because it will raise the temperature of everything surrounding the panels. This will affect the soil as it will be environmentally detrimental and there is not enough long term information to know what impact that the the toxins that could leak, would have.

Risk of Fire (we already have issues with fire risk in Summer) having such a volatile and unknown risk with these panels is very unsettling. We are in drought conditions most summers, and with this there are additional risks and we do not have the people here to fight a fire of this magnitude if it were to break out. Our Volunteer Fire Brigade already work tirelessly to protect our community and if fire does break out they will need to monitor it because there is nothing can be done to fight the fire from the batteries/panels. The community would need to abandon the town and likely the town would be destroyed.

Insurance - Risk factors are taken into account and this is a risk factor that we have no control over, likely to drive up the price of our premiums

Community Impacts - House prices, Reduced Visitors, Scenery

The community will all be affected by this with reduced visitors, impacting the businesses. House prices will fall as new residents will be put off by the panels. The scenery of the area will not be the same and regardless of how many trees are planted you will still be able to see the panels from different locations and look out points due to the size of the panels/batteries

#### Safety of the road - Glare

This is concerning as there are already locations around the place where sunstrike is concerning at certain times of day. Due to the locals and tourists driving through central travelling that road, it is concerning the risk of Glare and sunstrike from these panels

Back up plan if there is a fire and resources to fight a fire There is no plan for what happens if there is a fire - There is nothing that can be done to fight this and the community would not likely be able to get out of town quick enough. You are putting people at risk by allowing this consent to go ahead.

Outside of the building code - It will spoil the iconic Central Otago Landscape - This structure does not fit.

Nightsky - The new Dark Sky Precinct (DSP) covers the

Naseby Township and surrounding area. What will the impact be on this - a new community initiative to drive visitors numbers. We will we loose this and therefore another family and business who will need to move on.
