Possible impact on Naseby's dark skies application due to the effect of glare from the panels

1) During its construction period, the proposed solar farm is likely to have a severe impact on local tourism and potentially on the viability of the Otago Central Rail Trail. The Maniototo is a key staging point on the Trail, with the majority of Trail users spending at least 1 night staying in the area. According to Tourism Central Otago there are only 150 rooms available for tourists each night. The applicant has stated that they will have 250 workers engaged on the project throughout the 2 year construction period! Nowhere in their submissions has the applicant stated how it will provide accommodation for its construction team. On the face of it, the net effect during construction will be to exclude tourists from finding accommodation in the area during the main September - May tourist season.

The OCRT brings thousands of visitors into the area each season and it contributes hundreds of thousands of dollars to the Maniototo economy. With a critical shortage of accommodation during the construction phase of the proposed project, this vital revenue stream, together with local jobs will be at risk. This will also impact local visitor attractions such as the Maniototo Adventure Park, sports tourments and any other large event planned by organisations over the construction period. It is apparent from the applicant's submissions that the proposed solar farm will produce no economic benefit for the area once construction is completed, whereas tourism is a significant long-term contributor to the local economy.

2) Maniototo is renowned for spectacular, attractive rural landscapes which will be scarred for the next 35 years by the unattractive vastness of the proposed solar farm. I support the development of solar energy of considerably smaller size and in more discreet and largely hidden locations. While its good to see that the applicant proposes to plant trees along key boundaries, it may take years for plantings to screen out the proposed solar farm, particularly because there seems to be little offset between the panels and the Ranfurly-Naseby Road. Naseby attracts thousands of tourists and holidaymakers each year and continues to grow in popularity. Sadly, if the solar farm application is granted, Naseby visitors will be greeted by what would be second only to an industrial wasteland and probably one of the ugliest approaches to any town in NZ, unless the visual impact of the proposed farm are fully mitigated.

3. While it is acknowledged that the applicant has undertaken extensive work into the affects of glare on neighbouring properties, It seems that no consideration has been given to Naseby's pending International Dark

Skies application and any possible impact that glare from the panels may have during full moon and other periods. The Naseby community has invested hundreds of hours to bring this project to fruition and the applicant needs to demonstrate that glare from its panels will not affect the community's pending status.
