Pursuant to clause 5 of the First Schedule to the Resource Management Act 1991 the Central Otago District Council has accepted a request to consider the following change to the Central Otago District Plan (the proposal). Plan Change 23 has been requested by Hartley Road Partnership, and this request was accepted for consideration by the Council

Plan Change 23 - Hartley Road Partnership

on 30 October 2024

The site is legally described as Section 1 Block XXXIV Town of Clyde; Part Block XXXI Town of Clyde; Block XXXII Town of Clyde; Part Block XXXIII and Part Block XXXIV Town of Clyde and contained in Record of Title 51710 (title area 6.1663 ha), and located on the north-eastern corner of the intersection of State Highway 8 and Springvale Road and bounded by the Clyde Cemetery and Clyde Town Belt.

The request proposes to rezone 5.6 hectares of land from Rural Resource Area to Industrial Resource Area and to retain the balance land of the subject site as the Rural Resource Area.

The Plan Change also proposes the following amendments to the operative District Plan:

- An addition to Rule 12.7.1. (iii) Access to Rural State Highways and Arterial Roads, to provide that there be no direct access to any subdivided allotment from the site to SH8 and Springvale Road and to provide for a suitable left turning lane from State Highway 8 into Springvale Road.
- An addition to Rule 9.3.5 (iv) Screening to provide for a 10m landscaped buffer strip along the boundaries of the site with State Highway 8, Springvale Road and the Clyde Cemetery Reserve.
